

**EASTMAN KODAK COMPANY'S**  
**Free to Print Contest**  
**OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN.  
A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.  
VOID WHERE PROHIBITED.**

The KODAK "Free to Print" Contest (the "Contest") will commence at 12:00 PM (EST) on January 17, 2007 and end at 11:30 PM (EST) on February 15, 2008. Eastman Kodak Company's computer is the official time-keeping device for the Contest.

**SPONSOR/ADMINISTRATOR:** The sponsor and administrator of this Contest ("Sponsor") is Eastman Kodak Company, 343 State Street, Rochester, NY 14650.

**ELIGIBILITY:** The Contest is open to anyone who has access to the Internet, who is 18 years of age or older at the time of entry, is a legal resident of the United States and residing in the 50 United States. Employees, officers and directors of Eastman Kodak Company (including immediate family members and/or those living in the same household), their agents; affiliates; subsidiaries; advertising and promotion agencies; and those involved in the production, development, implementation or handling of this Contest are not eligible to enter this Contest. By entering into the Contest, participants agree to release, discharge and hold harmless the Sponsor, their respective parents, affiliates, subsidiaries, agents, representatives, retailers, agencies and their respective officers, directors, employees and agents, from any and all liability, claims, losses, injuries, demands, damages, actions, and/or causes of actions whether direct or indirect, which may be due to or arise out of participation in the Contest or any portion thereof, or the acceptance, use/misuse or possession of prizes. By entering into the Contest, the participant shall be deemed to have read and agreed to be bound by these Official Rules, and by the decisions of Sponsor and its affiliated entities, which shall be final and binding in all respects. The decisions of the judges are final and binding in all respects. Void where prohibited by law, rule or regulation. All federal, state and local laws and regulations apply.

**HOW TO ENTER:** Visit [printfreedom.kodak.com](http://printfreedom.kodak.com). Click on the contest promotion link to access the contest page. Entries are made via comments. Click on "comments" below the comments section, and then click "Add Your Comment". To post your entry, complete the form with your name and email address, and post your entry in the comment section. Type in the security code in the box provided and click submit. Your entry will appear as a comment on the contest page. Your comments should explain what you would do now that you are free to print more with a KODAK EASYSHARE All-in-One Printer. You must use or mention the KODAK EASYSHARE All-in-One Printer in your entry. The entry must not contain material that violates or infringes another's rights, including but not limited to privacy, publicity or intellectual property rights, or that constitutes copyright infringement. The entry must not contain brand names or trademarks. The entry must not contain images or artwork not created by entrant. The entry must not contain material that is inappropriate, indecent, obscene hateful, tortuous, defamatory, slanderous or libelous. The entry must not contain material that promotes

bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, sex, religion, nationality, disability, sexual orientation or age. The entry must not contain material that is unlawful, in violation of or contrary to the laws or regulations in any state where entry is created. You may enter as many unique entries as desired during the Contest. All entries must be submitted by February 15, 2008. To claim a prize, you must provide your correct name, mailing address, telephone number, social security number, and email address. Sponsor is not responsible for late, lost, misdirected, or invalid entries.

**JUDGING/PRIZES:** Four (4) winners will receive a \$250 KODAK Store credit for a one-time shopping spree. Winners may spend up to, but not exceed, \$250 on products at the KODAK Store. Any remaining value after purchase cannot be redeemed for cash. Winners will not be responsible for sales tax or shipping and handling charges.

A weekly winner will be chosen by random draw from the ten highest scoring entrants for that week. A qualified panel of judges will judge entries (posts) based on creativity (50%) and content (50%). Creativity is based on originality and uniqueness of entry and content is based on appropriate use of and recognition of Kodak's ink savings message regarding lower priced inks and affordable printing. In the case of a tie, the entry with the highest creativity score will be determined as the higher scoring entry. In the case of a further tie, the winner will be determined by the Sponsor, in its sole discretion.

**PRIZE AWARDING:** Weekly Judging will occur on or about January 30, February 6, 13, and 20, 2008. Final Judging will declare the winners, upon verification of eligibility and compliance with these Official Rules. ALL FEDERAL, STATE AND LOCAL TAXES ASSOCIATED WITH THE RECEIPT OR USE OF THE PRIZE ARE THE SOLE RESPONSIBILITY OF THE WINNER. All costs and expenses not specified herein are the sole responsibility of the winner. No prize substitution, cash equivalent of prizes, transfer or assignment of prize permitted, except by Sponsor, in its sole discretion, due to prize unavailability for any reason, and only then for a prize of equal or greater value. If winner of any prize is a minor, prize will be awarded to the parent or legal guardian. Prize is not transferable, except at discretion of Sponsor. Limit one (1) prize per household/family/person. Sponsor is not responsible in the event that the participant provides any incorrect, expired, or otherwise invalid information. Once you submit your entry, you will be officially entered into the Contest. Entries cannot be revised or altered once submitted. Once submitted, all submitted components become the property of Eastman Kodak Company. Sponsor shall have the right to disqualify any entries that they deem to be obscene, vulgar, sexually explicit, lewd, derogatory, inappropriate, or otherwise not in good taste, as determined by Sponsor in their sole discretion.

**CONDITIONS OF PARTICIPATION; NOTIFICATION OF WINNER:** As a condition of participation in the Contest, each participant acknowledges and agrees that, subject to applicable law, Sponsor reserves the right to use all submissions to the Contest for promotional purposes, including, without limitation, advertising and/or any other promotional purposes without additional compensation to the winner. Prize winners may be required to sign and return, without limitation and to the extent permitted under applicable law, an Affidavit of Eligibility, a Liability Release, a Publicity Release and any other documentation or instrument that Sponsor may

require within five (5) days of receiving each such document. If the winner is under 18 years of age, they will need a parent or legal guardian to complete the above paperwork. In the event of noncompliance with these requirements, Prize Winners may be disqualified and an alternate winner may be selected, at Sponsor's sole discretion. If a potential winner is contacted by email for verification purposes, he/she will have three (3) business days within which to respond to the notification email, or he/she will be disqualified and his/her prize forfeited, and an alternate potential winner may be selected. If a participant changes his/her email address or other contact information after he/she enters the Contest, it is his/her sole responsibility to update his/her information by logging in and making changes in his/her account. Failure to update such registration information may affect a potential winner's ability to receive a prize. If a potential winner cannot be reached after a reasonable effort has been exerted, he/she is found to be ineligible, he/she cannot or does not comply with these official rules, or if a prize or prize notification is returned as undeliverable, such potential winner will be disqualified, and an alternate potential winner may be selected at Sponsor's sole discretion. Each participant agrees that upon submission of any content to the Contest hosted on [printfreedom.kodak.com](http://printfreedom.kodak.com), such content will remain on the site in perpetuity or for as long as Sponsor deems appropriate to archive. Specifically, once submitted to the Contest, participants release the right to remove entries from the Contest at any point during or after the Contest has concluded.

Each winner will be notified by Eprize via email within approximately two (2) weeks of the given Contest's judging results tally. In that email, each winner will be given details of the shopping spree by Eprize. Winners will be asked to create a shopping list of products that includes product description, item number and price as noted on the KODAK Store. Winners will have thirty (30) days to provide a qualified product list to Eprize. If the list contains more than \$250 in KODAK Store products it is not considered a qualified list. Winners will be contacted by Eprize and asked to remove product(s) from list until total product costs equal \$250 or less. Once qualified list is received from winner, order will be processed for shipment. Please allow 5-7 weeks for prize delivery.

Subject to applicable law, participation in the Contest constitutes permission for Sponsor to use all Winners' names, likenesses, and entries for advertising and promotional purposes without additional compensation, across all media now known or hereafter devised, in perpetuity. Sponsor reserves the right to modify the terms and conditions at any time during the Contest.
